VOLATILES GAS CHROMATOGRAPHY

In the RSK 175 analysis, all samples had to be diluted to bracket the concentrations within the calibration range of the instrument. The recoveries for the surrogates are not applicable for those analyses performed at a 10 or higher dilution.

In the RSK 175 analysis for analytical batch 494958, the MS/MSD recoveries and RPDs are not applicable for Methane and Ethane because the spike was diluted out of the samples. The LCS/LCSD recoveries are acceptable.

Laboratory Endorsement

Sample analysis was performed in accordance with approved methodologies provided by the Environmental Protection Agency or other recognized agencies. The samples and their corresponding extracts will be maintained for a period of 30 days unless otherwise arranged.
