Starting and stopping some equipment including pumps and compressors have an effect on flare flows. - MIT on Dow 17 and Dow 22 Wednesday through Friday. This will involve a portable pump and wire line company equipment. - Install brine pump at pump area north of Hwy 70 this will require. (Blue Cherry Picker) - Water to Chevron for re-watering.
