Flows to these flares are dependent on the equipment in operation at the time. Starting and stopping some equipment including pumps and compressors have an effect on flare flows.- Dow 8/8A workover activity – will be pulling piping this week. Preparing for MIT.- Replacing piping spools near Dow 9/9A.- Sandblasting and painting at the P-80's pumps north of Hwy 70.- Dow 5 removing temporary piping from wellhead.- Water to Chevron for re-watering

A portable flare is set up on for de-pressuring a pipe section. - Replace pipe spool section Dow 9 area (routine maintenance) this week - week of 12/03. - Cleaning sump under coalescers. Requires use of roll off bins to remove sand and allow to drain – work will continue the week of 12/3 - Respond to Public Agency Request
