The Commissioner of Conservation, pursuant to Chapter 1 of Title 30 (LSA-R.S. 30:21), proposes to amend LAC 43:XIX, Subpart 2, Chapter 7. The following report regarding proposed Statewide Order No. 29-R-16/17 is submitted to you in accordance with LSA-R.S. 49:968(B) and (C).

In accordance with La R.S. 49:968.B and C. the Commissioner forwarded a report (dated August 10, 2016) of proposed amendments to the appropriate legislative committees, presiding officers of the House and Senate, and other state offices.

The public comment period was held open until 4:30 PM September 12, 2016. Pursuant to La R.S. 49:968.D(1)(b), the Commissioner of Conservation submits the following summary report of the public hearing.
