Responses

- 1- There was no way of measuring the amount of fluids in any of the tanks. Do you want to give the Contractors an estimate of the number of bbls for disposal so that we will all be bidding on the same number? Or is the \$\$/bbl for disposal that you just sent in the addendum to reflect the actual trucking to get it to disposal and disposed of or just disposal itself??? The cost per barrel requested on page 20A should include all costs to remove and dispose of any fluids contained in the tanks/production facility area. It should not be a total cost for removal, as we do not know the total amount of fluids to be removed.
- 2- Do you know how many water wells are on location that need to be P&A'd? There are two (2) water wells on site that will have to be plugged. These costs must be included in the bid.
- 3- Under some of the concrete slabs we noticed pilings. Can you give us an estimate on how many pilings should be bid on to be removed as we couldn't see under all of the slabs? This way we can bid the same numbers. OSR does not know the number of pilings that will have to be removed. Please include the price to remove one piling in your bid.
