SECOND SUPPLEMENTAL AND AMENDING PETITION FOR DAMAGES

NOW INTO COURT, come Plaintiffs, New 90, LLC and James J. Bailey, III, individually and as representative of the Successions of Willie Palfrey Foster and Fairfax Foster Bailey, through undersigned counsel, who respectfully file this Second Supplemental and Amending Petition for Damages by incorporating *in extenso* their original Petition for Damages and First Amended Petition for Damages, and by supplementing and amending said petitions as follows:

T.

By amending Paragraph 1 of the original Petition for Damages to remove Louisiana Wetlands, LLC as party plaintiff and to add a new party plaintiff as follows:

BP is named as successor in interest to Pan-American Production Company, Amoco Production Company, Lear Petroleum Exploration, Inc., and Lear Petroleum Corporation."

IV.

By substituting the **Exhibit A** attached to the original Petition for Damages listing Defendants' wells for the revised **Exhibit A** attached hereto.

WHEREFORE, Plaintiffs pray that Defendants be cited to appear and answer this petition and that after due proceedings had, that there be judgment entered herein as follows:

1. Awarding Plaintiffs compensatory damages in an amount to be proven at trial, including payment of the costs to restore land loss and restore lands with identified pollution to its original unpolluted state, unjust enrichment damages for the unauthorized disposal of waste on Plaintiffs' property without landowners' consent, civil fruits resulting from Defendants' illegal and bad faith trespass on Plaintiffs' lands, and other property damages;

Awarding Plaintiffs punitive damages; 2.

3. Ordering Defendants to pay Plaintiffs sufficient funds so that Plaintiffs may conduct a comprehensive and expedited environmental assessment of Plaintiffs' land to identify all hidden or not yet identified pollution on Plaintiffs' land;

Awarding Plaintiffs all costs of this suit and for legal interest therein for any amount 4. awarded from the date of judicial demand until paid; and further awarding Plaintiffs judicial interest on all contract claims from the date of breach;

5. Awarding Plaintiffs stigma damages for diminution in property value before and after restoration;

6. Ordering a mandatory and prohibitory injunction to restore Plaintiffs' property to its pre-contaminated condition and to prevent the migration and spread of toxic and hazardous substances onto Plaintiffs' property;

8. For all costs and attorneys' fees pursuant to La. R.S. 30:29 and any other applicable provision of law;

9. For all just and equitable relief; and

10. For all damages as are reasonable in the premises.
