**Call to Order**

Scott Bergeron, Chairman of the Advisory Committee, called the meeting to order at 12:00 p.m. with welcoming remarks. The Roll was called and a quorum was established.

**Review of New Applicants for Louisiana Driller's License**

1. The application for Michael Kosydor, of Geotechnology, Inc. was reviewed by the Committee. Herschel Bourque made the motion to accept the application; seconded by Jake Causey. The motion passed unanimously.
