## OLD BUSINESS

- Levee Board Update (R. Minsky) has been in discussion with COE about chipping trees and snags in the Tensas, similar to DOTD roadside chipping. COE is in favor. Could potentially happen this year, though delays from COVID are expected. Mr. Minsky will meet with the new Vicksburg District General, who begins in June.
- Approval of Watershed Report (T. Van Biersel) report has been accepted, will submit as soon as legislature resumes. Need to ask DOTD for extension for application for flood control funding. The current deadline is Oct. 2020. Andy can assist Roger with extension request.
- LDWF Lake Report (R. Daniel) LDWF will be conducting electrofishing sampling in spring and fall 2020; plans to assess growth rates to determine if any growth impairment due to water quality or other factors
- Police Jury Update (R. Clement) looking for funding for control structure repairs. ECPPJ will try to clean out Baxter Bayou in vicinity of lake and structure. Still working on a final list for road swap with LDOTD. Potential for FEMA funding. May not be including Hwy. 596 in road swap. Delays due to COVID.
- A. Vincent (LDEQ) reported that most field sampling has been temporarily suspended.
- LWI Update (F. Lensing) no new news. Lensing attended 3 meetings past winter. ECPPJ has new member who will begin working on LWI project.
- Renewal of the Council A. Brister submitted request to extend Council. Legislators have been notified. T. Van Biersel noted that he has not seen that it has been filed yet. A. Brister believes that Sharon at Rep. Thompson's office has communicated with Sen. Jackson's office.
