LOCATION: **Saint Mary Parish, LA;** OA A0276 Well No. 2/POB pipeline removal/abandonment: Lat 29° 24' 48"N / Long -91° 23' 48"W (NAD 83); X = 1,979,891 / Y = 271,422 (NAD 27); POE pipeline removal/abandonment: Lat 29° 24' 46"N / Long -91° 23' 24"W; South Atchafalaya Bay Field; Atchafalaya Delta Wildlife Management Area; Approximately 20 miles south-southwest of Morgan City, LA.

DESCRIPTION: Proposed removal of OA A0276 Well No. 2 (SN 179195) 15' below the mudline, 7' x 19' well protector platform, five existing 3-pile clusters and the removal/abandonment of +/- 2,308' of 4" pipeline. Approximately 2,166 cubic yards of material will be displaced by jetting for the removal. No dredging for access required.
