DESCRIPTION: Unauthorized fill deposition of dirt material on either side of an old city service road. Proposed filling of two old turtle ponds: one is 120' x 85' and the other is approx. 360' x 90'. A total of 6,000 cu. yds. of dirt material will be used as fill for this project. Land was previously cleared prior to being in the Louisiana Coastal Zone. No wetlands have been impacted by this activity since the LA Coastal Zone boundaries have changed. An Administrative Penalty will be issued for the unauthorized activities.
