Interested parties are hereby notified that in accordance with LA R.S. §49:214.35 and LAC Title 43, Chapter 7, §723.C.6.e the Office of Coastal Management of the Department of Natural Resources will hold a Public Hearing concerning the following request for reconsideration of a Coastal Use Permit decision. Interested parties are hereby notified that a Public Hearing will be held on Thursday January 28, 2021 at 1:00pm in the Griffon Room, La Salle Building, located at 617 North Third Street, Baton Rouge, LA 70802. LOCATION: St. James Parish, LA; P.O.B. Lat. 29-57-04.35N, Long. -90-53-08.40W and P.O.E. Lat. 30-03-44.01N, Long. -90-49-47.18W (see plats for additional project coordinates); approx. 9.9 miles southeast from Vacherie.

DESCRIPTION: Proposed installation of one 16" Oxy Convent Brine Pipeline (~10.5 miles in length) using traditional trenching/open cut and horizontal directional drilling methods. The proposed pipeline will parallel an existing pipeline corridor along the southern portion of the proposed route. Excavation (44,472 c.y.) will be temporarily stockpiled and backfilled upon completion of the pipeline installation. Rock material (1,746 c.y.) will be placed within each valve site and hauled in topsoil/dirt (77.4 c.y.) will be required for temporary culverts. Approx. 40 acres of forested wetlands, fresh marsh, and uplands may be impacted by proposed activities.
