DESCRIPTION: Unauthorized expansion of drilling operations at the Watkins 277 and 278 wells in 2018. Activities included clearing, excavation of approximately 127 cu. yds. of material to construct a borrow ditch and ring levee in uplands and laying of approximately 0.31 acres of board matting in uplands and adjacent to but outside of the original permitted area. There was no impact to wetlands. An administrative penalty was issued and paid for the unauthorized activities. DESCRIPTION: Unauthorized dredge of approximately 800 cu. yds. of material from Bayou Lafourche and placed onto an area measuring approximately 296 ft by 20 ft or 0.137 acres of uplands. There was no impact to wetland habitat.
