DESCRIPTION: Unauthorized dredging of 1,166 cubic yards of material from Grand Caillou Bayou and placed on 0.24 acres of wetland embankment for erosion control. Impacts to 0.24 acres of fresh marsh were observed. A growing season may be conditioned to allow for the impacts to self-restore. The applicant will be required to provide compensatory mitigation for any permanent loss of wetlands. CUP Number **P20210190 ATF; Daniel J. DESCRIPTION: Unauthorized clearing of approximately 3 acres of mainly dead or rotten forested wetland. Approximately 1,613 cubic yards of soil was hauled in to fill in holes left behind from the removal of the trees. A growing season may be conditioned to allow for the tracking and clearing impacts around the removed trees to self-restore. The applicant will be required to provide compensatory mitigation for any permanent loss of wetlands caused by the activity.
