DESCRIPTION: Unauthorized construction of a 106ft vinyl bulkhead along a man-made canal to stop erosion. Wetland impacts were under 0.01 acre. DESCRIPTION: Unauthorized construction of 185ft bulkhead and boat launch with approximately 400 cubic yards of hauled in dirt placed behind it. Applicant proposes to construct a twenty-pad RV park on upland area adjacent the bulkhead and boat launch. Approximately 600 cubic yards of additional dirt and 350 cubic yards of crushed limestone are proposed to be used for the RV park. Compensatory mitigation will be required for impacts to 0.08 acres of fresh marsh and an administrative penalty may be issued for the unauthorized activity.
