The State Mineral and Energy Board acting on behalf of the Bossier Parish School Board and Caddo Parish School Board, pursuant to Resolution(s) adopted by that (those) body(ies) and in accordance with Louisiana Revised Statutes 30:121-136 and 151-156, as amended, and Article XIV, Section 16(A)(9) and (B) of the Louisiana Constitution of 1974, as same may be continued and promulgated in proper statutory form and, further, amended from time to time, advertises the lands not under mineral lease on September 10, 2014, excluding the beds and bottoms of all navigable water bodies located within the following: All or a portion of Section 16, Township 19 North, Range 14 West in Caddo Parish, Louisiana, **LESS AND EXCEPT** that portion lying within the CV RA SUE which unit was established by Order No. 1505 on May 22, 2007 in the Dixie Field, being 225.12 acres in the North Half of Section 16, lying below 3,000 feet from the surface, being **225.12 acres**, all as more particularly outlined on a plat on file in the Office of Mineral Resources, Department of Natural Resources. 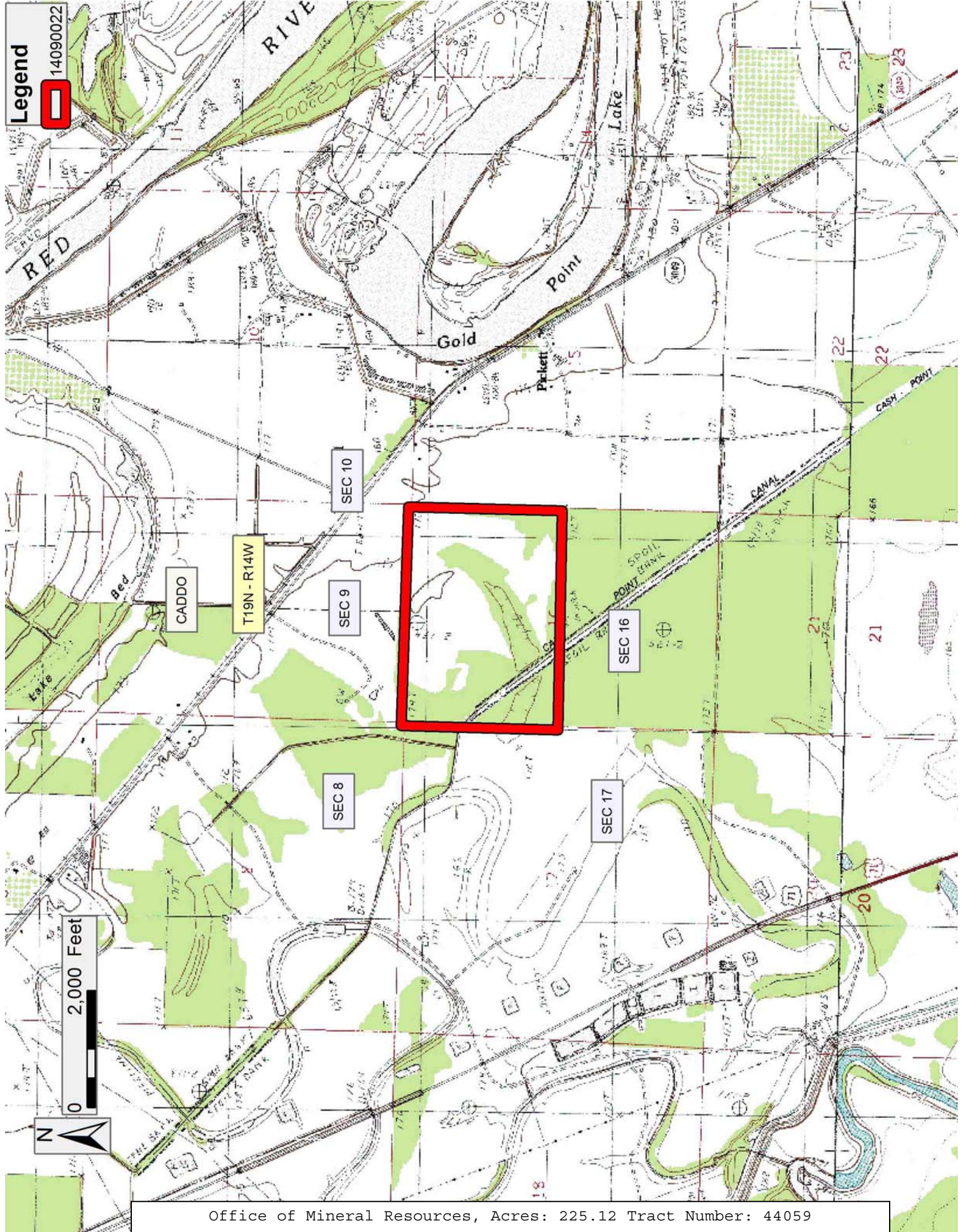

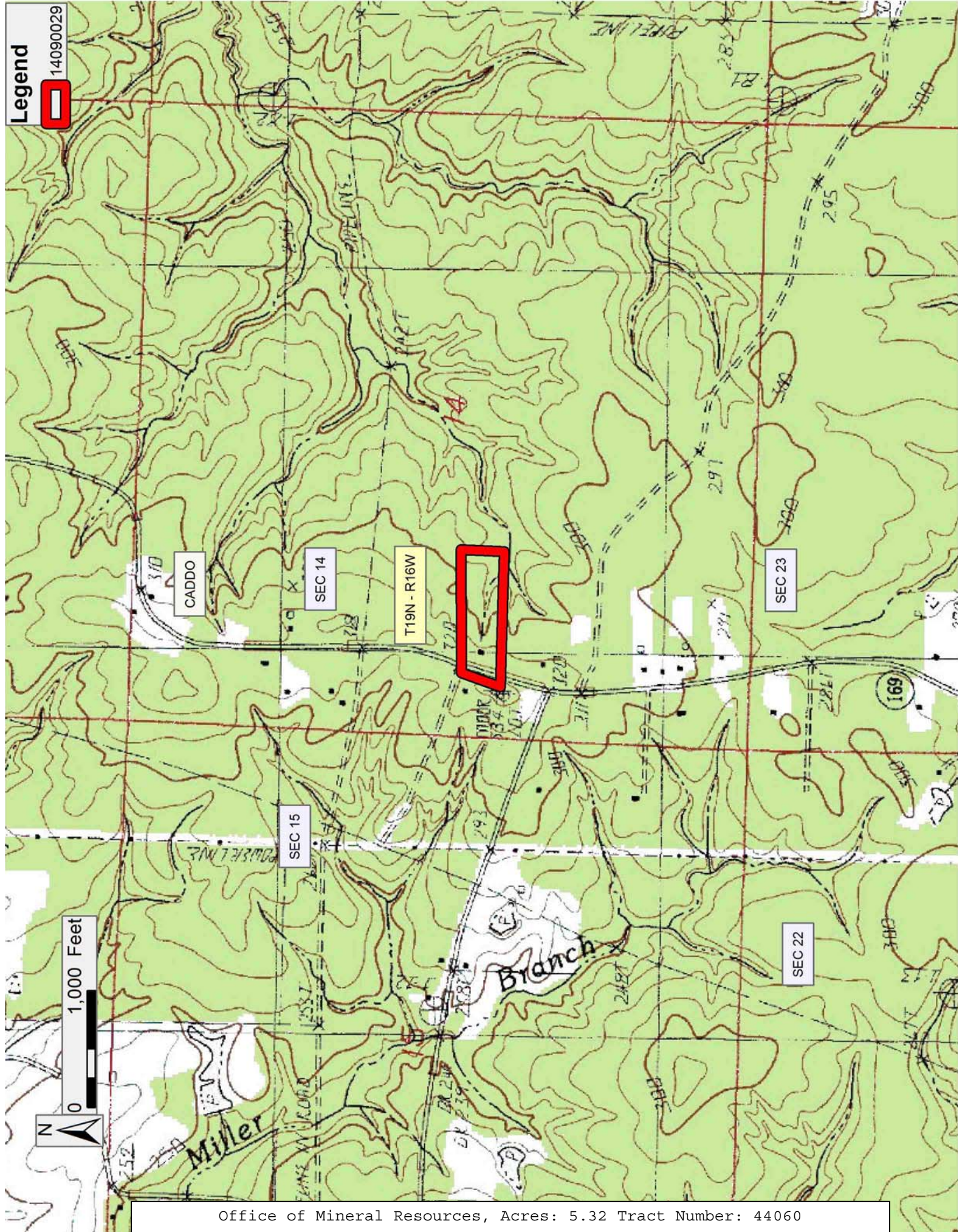

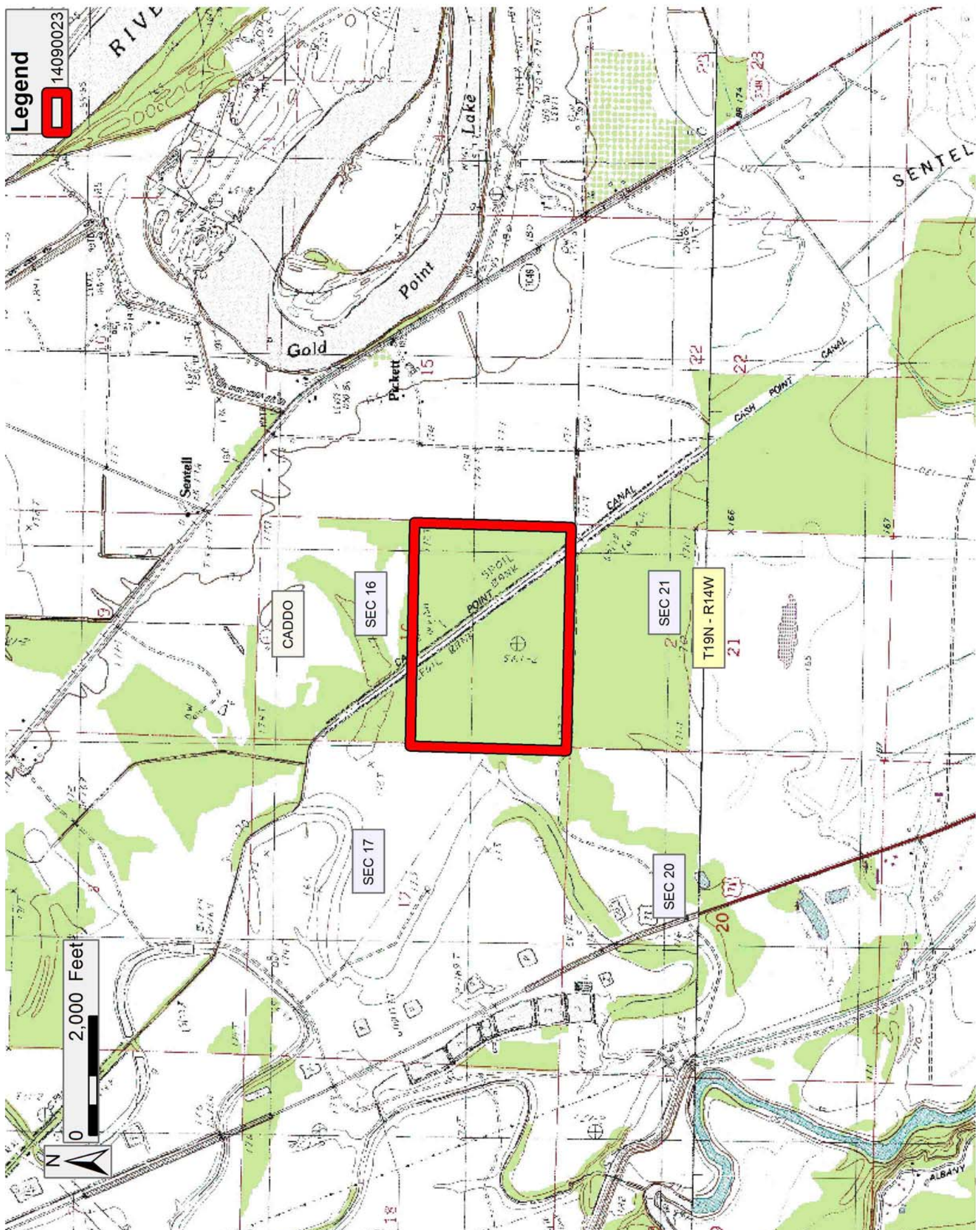
