**LEGAL NOTICE**

**STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.**

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Clarion Hotel Shreveport, Broadmoor Room, 1419 East 70<sup>th</sup> Street, Shreveport Louisiana, at 9:00 a.m. to 12:00 p.m. on **THURSDAY, OCTOBER 28, 2004**, upon the application of **J-W OPERATING COMPANY**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Hosston Zone, Reservoir A, to the Cotton Valley Formation, Reservoir A, and to the Lower Cotton Valley Zone, Reservoir A**, in the Elm Grove Field, Bossier and Caddo Parishes, Louisiana.

1. To permit Applicant to drill, designate and utilize one (1) additional alternate unit well for HOSS RA SU108, CV RA SU128 and for LCV RA SULL, at the location shown on plats submitted with the application.
2. To approve exceptions to the well location provisions of Office of Conservation Order No. 361-A-1, effective October 1, 1972, Office of Conservation Order No. 361-B, effective October 1, 1973, and Office of Conservation Order No. 361-E, effective July 16, 1996 for the proposed well.
3. To find that the proposed alternate unit well is necessary to efficiently and economically drain a portion of each of the units on which it is proposed to be drilled which cannot be efficiently and economically drained by any existing well on such unit.
4. To consider such other matters as may be pertinent.

The Hosston Zone, Reservoir A, was defined in Office of Conservation Order No. 361-A-1, effective October 1, 1972, and was further defined in subsequent Orders of the 361-A series of Orders.

The Cotton Valley Formation, Reservoir A, was defined in Office of Conservation Order No. 361-B, effective October 1, 1973, and was further defined in subsequent Orders of the 361-B series of Orders.

The Lower Cotton Valley Zone, Reservoir A, is defined in Office of Conservation Order No. 361-E, effective July 16, 1996.
