Application is hereby made on behalf of **WINCHESTER PRODUCTION COMPANY**, (Applicant), to the Commissioner of Conservation for a public hearing to consider evidence relative to the issuance of an Order pertaining to the following matters relating to the Cotton Valley Formation, Reservoir A, and the Hosston Formation, Reservoir A, Kingston Field, DeSoto Parish, Louisiana:

1. To permit the applicant to designate and utilize their Miller No. 1 Well as the unit well for HOSS RA SUF and CV RA SUF and to drill and designate and utilize their Crocker 7 No.1 Well as an alternate unit well, in exception to the spacing provisions of the 376-B and 367-C Series of Office of Conservation Orders, for the production of gas and condensate for the Cotton Valley Formation, Reservoir A, and the Hosston Formation, Reservoir A, in the units designated HOSS RA SUF and CV RA SUF, such units and well shown on the attached plat and being made a part hereof.
2. To find that additonal that the unit well and the alternate unit well are necessary to assist in draining a portion of the HOSS RA SUF and CV RA SUF that cannot be drained by any other well located therein.
3. To permit the unit operator to produce the assigned unit allowable from the unit well, the alternate unit wells or from a combination of all wells at its discretion.
4. To consider and cover such other matters as the Commissioner of Conservation may deem pertinent and appropriate.

The Cotton Valley Formation, Reservoir A, was defined in Office of Conservation Order No. 376-C, effective May 2, 1978 and the Hosston Formation, Reservoir A was defined in Office of Conservation Order No. 376-B, effective May 2, 1978, in the Kingston Field, DeSoto Parish, Louisiana.


