**LEGAL NOTICE**

**STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.**

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1<sup>st</sup> Floor, LaSalle Building, 617 North 3<sup>rd</sup> Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, DECEMBER 7, 2004**, upon the application of **HILCORP ENERGY COMPANY**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **E-3 Sand, Reservoir D**, in the Lake Barre Field, Terrebonne Parish, Louisiana.

1. To establish rules and regulations governing the exploration for and production of oil and gas from the E-3 Sand, Reservoir D.
2. To create a single drilling and production unit for this sand and to force pool and integrate all separately owned tracts, mineral leases and other property interests within the unit so created.
3. To designate Hilcorp Energy Company as operator of the E-3 RD SUA.
4. To designate Hilcorp's U17 Well No. 14 (SN 221677) as the unit well for the E-3 RD SUA.
5. To provide that any future replacement and/or alternate wells for said unit shall be exempt from the spacing provisions of Statewide Order No. 29-E.
6. To provide that the Commissioner may reclassify the reservoir by supplemental order and without the necessity of a public hearing should such reclassification be warranted, based on evidence furnished the Commissioner.
7. To consider such other matters as may be pertinent.

The E-3 Sand, Reservoir D, is hereby defined as being that oil and gas bearing sand encountered between the depths of 10,490' and 10,520' electric log measured depths in the Hilcorp Energy Company - U17 Well No. 14, located in Township 21 South, Range 19 East, Terrebonne Parish, Louisiana.
