LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m., on **TUESDAY, FEBRUARY 17, 2004**, upon the application of **KASH OIL & GAS, INC.**

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of an Order pertaining to the following matters relating to the **Homeseekers D-4 Sand, Reservoir E**, in the Rayne Field, Acadia Parish, Louisiana.

1. To establish rules and regulations governing the exploration for and production of gas and condensate from the Homeseekers D-4 Sand, Reservoir E.
2. To create a single drilling and production unit and to force pool and integrate all separately owned tracts, mineral leases and other property interests within the unit so created.
3. To designate a unit operator and a unit well for the proposed unit.
4. To provide that the Commissioner may reclassify the reservoir by supplemental order without the necessity of a public hearing should such reclassification be warranted, based on evidence furnished to the Commissioner.
5. To provide that any wells drilled to the Homeseekers D-4 Sand, Reservoir E, be exempt from the provisions of Statewide Order No. 29-E.
6. To consider such other matters as may be pertinent.

The Homeseekers D-4 Sand, Reservoir E, in the Rayne Field, Acadia Parish, Louisiana, is hereby defined as being that gas and condensate bearing sand between the measured depths of 13,900' and 13,938' (ELM) in The William G. Helis Company, L.L.C. - Louis T Graham No. 1 Well, located in Section 24, Township 9 South, Range 2 East.

A plat is available for inspection in the Office of Conservation in **Baton Rouge and Lafayette**, Louisiana.
