LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m., on **TUESDAY, FEBRUARY 10, 2004**, upon the application of **BP AMERICA PRODUCTION COMPANY**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of an Order pertaining to the following matters relating to the **Pettit Zone**, in the Spider Field, DeSoto Parish, Louisiana.

1. To permit the applicant to drill, designate and utilize its DeSoto Properties No. 2 Well as substitute unit well for the PET SUC, said well located on the plat submitted with the application, in exception to the spacing provisions of Office of Conservation Order No. 92-A, effective February 25, 1948.
2. To find that the proposed substitute unit well at the location shown on the plat submitted with the application, is necessary to efficiently and economically drain a portion of the reservoir covered by the unit in which it is situated which cannot be so drained by any existing well within such unit.
3. Except to the extent contrary herewith, to continue in full force and effect the provisions of Office of Conservation Order No. 92-A, as amended and supplemented by the 92-A Series of Office of Conservation Orders, the units created thereby and applicable Statewide Orders.
4. To consider such other matters as may be pertinent.

The Pettit Zone, in the Spider Field, DeSoto Parish, Louisiana, was defined in Office of Conservation Order No. 92-A, effective February 25, 1948.

A plat is available for inspection in the Office of Conservation in **Baton Rouge** and **Shreveport**, Louisiana.
