

**LEGAL NOTICE**

**STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.**

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m., on **TUESDAY, APRIL 27, 2004**, upon the application of **WINCHESTER PRODUCTION CO.** At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of an Order pertaining to the following matters relating to the **Glen Rose Formation, Reservoir A**, in the Holly Field, DeSoto Parish, Louisiana.

1. To permit the applicant to drill, designate and utilize an alternate unit well, the Winchester Production Company - Fuller 24 No. 3 Well, in exception to the spacing provisions of the 88-H Series of Office of Conservation Orders, for the production of gas and condensate for the Glen Rose Formation, Reservoir A, in the unit designated GR RA SUD, such unit and well shown on the plat submitted with the application.
2. To find that an alternate unit well is needed on the GR RA SUD to assist in the efficient and effective drainage of the Glen Rose Formation, Reservoir A, that cannot be drained by any other well located therein.
3. To permit the unit operator to produce the assigned unit allowable from the unit well, the alternate unit well or from a combination thereof at its discretion.
4. To consider such other matters as may be pertinent.

The Glen Rose Formation, Reservoir A, in the Holly Field, DeSoto, Louisiana, was defined in Office of Conservation Order No. 88-H, effective October 31, 2001.

A plat is available for inspection in the Office of Conservation in **Baton Rouge** and **Shreveport**, Louisiana.
