

LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m., on **TUESDAY, MAY 4, 2004**, upon the application of **CAMTERRA RESOURCES, INC.**

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of an Order pertaining to the following matters relating to the **Hosston Zone, Reservoir A, Cotton Valley Formation, Reservoir A and the Lower Cotton Valley Zone, Reservoir A**, in the Elm Grove Field, Caddo Parish, Louisiana.

1. To permit the applicant to drill, designate and utilize two (2) additional alternate unit wells for the HOSS RA SU11, CV RA SU11, LCV RA SU66, one (1) additional alternate unit well for the HOSS RA SU13, CV RA SU13 and the LCV RA SU59, one (1) additional alternate unit well for the HOSS RA SU24, CV RA SU24 and LCV RA SUA and four (4) additional alternate unit wells for the HOSS RA SU25, CV RA SU25 and LCV RA SUL for the production of gas and condensate from the Hosston Zone, Reservoir A, the Cotton Valley Formation, Reservoir A and the Lower Cotton Valley Zone, Reservoir A, in exception to the spacing provisions of the 361-A, 361-B and the 361-E Series of Office of Conservation Orders, such units and wells shown on the plats submitted with the application.
2. To find that additional alternate unit wells are needed on each unit to assists in draining a portion of each unit that cannot be drained by any other well located therein.
3. To permit the unit operator to produce the assigned unit allowable from the unit well, the alternate unit wells or from a combination thereof at the discretion of the unit operator.
4. To consider such other matters as may be pertinent.

The Hosston Zone, Reservoir A, in the Elm Grove Field, Bossier, Caddo and Webster Parishes, Louisiana, was defined in the 361-A Series of Office of Conservation Orders, the Cotton Valley Formation, Reservoir A, was defined in the 361-B Series of Office of Conservation Orders and the Lower Cotton Valley Zone, Reservoir A, was defined in Office of Conservation Order No. 361-E, effective July 16, 1996.

A plat is available for inspection in the Office of Conservation in **Baton Rouge and Shreveport**, Louisiana.
