

LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, JULY 13, 2004**, upon the application of **CYPRESS OPERATING, INC.**

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Thatcher Sand, Reservoir A**, in the Lisbon Field, Claiborne Parish, Louisiana.

1. To establish one (1) additional unit for the exploration for and the production of gas and condensate for the Thatcher Sand, Reservoir A, such unit being designated THATCHER RA SUD, shown on the plat submitted with the application.
2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within each of the proposed units in accordance with Section 10, Title 30, of the Louisiana Revised Statutes of 1950, with each tract to share in the unit production on a surface acreage basis of participation.
3. To designate Cypress Operating, Inc. as the unit operator for the proposed THATCHER RA SUD and their Hunt No. 1 Well as the unit well, in exception to the spacing provisions of the 9-X Series of Office of Conservation Orders.
4. To extend the provisions of the 9-X Series of Office of Conservation Orders and other applicable statewide orders to the Thatcher Sand, Reservoir A unit being proposed herein, except as they may be in conflict herewith.
5. To consider such other matters as may be pertinent.

The Thatcher Sand, Reservoir A, in the Lisbon Field, Claiborne Parish, Louisiana, was fully defined in Office of Conservation Order No. 9-X, effective January 18, 1979.

A plat is available for inspection in the Office of Conservation in **Baton Rouge** and **Shreveport**, Louisiana.
