

LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, JULY 20, 2004**, upon the application of **HUNT OIL COMPANY**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Cockfield Zone, Reservoir C**, in the East Perkins Field, Beauregard and Calcasieu Parishes, Louisiana.

1. To establish rules and regulations and to create a single drilling and production unit for the exploration for and production of gas and condensate from the Cockfield Zone, Reservoir C, said unit to be designated CF RC SUA, as shown on the plat submitted with the application.
2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed unit with each tract sharing in unit production on a surface acreage basis of participation.
3. To provide that any future wells drilled to the Cockfield Zone, Reservoir C should be located in accordance with the spacing provisions of Statewide Order No. 29-E.
4. To provide that the Commissioner of Conservation should be authorized to reclassify the Cockfield Zone, Reservoir C, by supplemental order without the necessity of a public hearing if the producing characteristics of the reservoir change and evidence to justify such reclassification is submitted to and accepted by the Commissioner of Conservation.
5. To consider such other matters as may be pertinent.

The Cockfield Zone, in the East Perkins Field, Calcasieu Parish, Louisiana, was previously defined in the 986-B Series of Office of Conservation Orders.
