BRIDAS ENERGY USA, INC. ("Applicant"), hereby respectfully applies for a public hearing to consider evidence relative to the issuance of an Order pertaining to the following matters relating to the Paluxy Zone, Reservoir A, in the Bethany-Longstreet Field, DeSoto Parish, Louisiana:

1. To authorize Applicant to complete, designate and utilize its J. B. Barr No. 2 Well, located as shown on the attached plat, as the unit well for P SU HH, in exception to the well location provisions of Office of Conservation Order No. 289-H, effective December 1, 1973.
2. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Paluxy Zone, Reservoir A, in the Bethany-Longstreet Field, DeSoto Parish, Louisiana, was defined in Office of Conservation Order No. 289-H, effective December 1, 1973.

Pertinent data concerning this application is available for inspection at the offices of Louis Gilbert & Associates, Inc., 3636 North Causeway Boulevard, Suite 204, Metairie, Louisiana 70002-7216. As provided by the Revised Rules of Procedure, the subject matter of this application does not require the issuance of a pre-application notice; therefore, no such notice has been issued.


