

**LEGAL NOTICE**

**STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.**

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1<sup>st</sup> Floor, LaSalle Building, 617 North 3<sup>rd</sup> Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, AUGUST 17, 2004**, upon the application of **KERR-MCGEE OIL & GAS ONSHORE, L.L.C.**

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Y-2 Zone, Reservoir B**, in the DeQuincy Field, Calcasieu Parish, Louisiana.

1. To establish rules and regulations and to create a single drilling and production unit for the exploration for and production of gas and condensate from the Y-2 Zone, Reservoir B, said unit to be designated Y-2 RB SUA, as shown on the plat submitted with the application.
2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed unit with each tract sharing in unit production on a surface acreage basis of participation.
3. To provide that any future wells drilled to the Y-2 Zone, Reservoir B, should be located in accordance with the spacing provisions of LAC 43:XIX.1901 et seq (Statewide Order No. 29-E).
4. To provide that the Commissioner of Conservation should be authorized to reclassify the Y-2 Zone, Reservoir B, by supplemental order without the necessity of a public hearing if the producing characteristics of the reservoir changes and evidence to justify such reclassification is submitted to and accepted by the Commissioner of Conservation.
5. To consider such other matters as may be pertinent.

The Y-2 Zone, Reservoir B, in DeQuincy Field, is hereby defined as being that gas and condensate bearing zone encountered between the depths of 8,990 feet and 9,689 feet (electrical log measurements), in the Samedan Oil Corporation - Temple-Inland 25 No. 1 Well, located in Section 25, Township 7 South, Range 11 West, Calcasieu Parish, Louisiana.
