LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Clarion Hotel Shreveport, Broadmoor Room, 1419 East 70th Street, Shreveport, Louisiana, at 9:00 a.m. on **THURSDAY, OCTOBER 6, 2005**, upon the application of **KCS RESOURCES, INC.**

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Hosston Zone, Reservoir A; the Cotton Valley Formation, Reservoir A; and the Lower Cotton Valley Zone, Reservoir A**, in the Elm Grove Field, Bossier Parish, Louisiana.

1. To authorize KCS Resources, Inc. to drill, complete and utilize a unit well and an alternate unit well on HOSS RA SU112 and LCV RA SUHH at the exceptional locations shown on the plats submitted with the application.
2. To authorize KCS Resources, Inc. to drill, complete and utilize two alternate unit wells on CV RA SU108 at the exceptional locations shown on the plat submitted with the application.
3. To find that each of the proposed wells is necessary to efficiently and effectively drain a portion of the Hosston Zone, Reservoir A; the Cotton Valley Formation, Reservoir A; and the Lower Cotton Valley Zone, Reservoir A, underlying the respective units which cannot be efficiently and effectively drained by any other well.
4. To authorize the unit allowable for these Hosston Zone, Reservoir A; Cotton Valley Formation, Reservoir A; and Lower Cotton Valley Zone, Reservoir A, units to be recovered from any of the wells located on the units, at the discretion of the operator.
5. To consider such other matters as may be pertinent.

The Hosston Zone, Reservoir A was defined in Office of Conservation Order No. 361-A-1, effective October 1, 1972, and was further defined in subsequent Orders of the 361-A Series of Office of Conservation Orders.

The Cotton Valley Formation, Reservoir A was defined in Office of Conservation Order No. 361-B, effective October 1, 1973, and was further defined in subsequent Orders of the 361 Series of Office of Conservation Orders.

The Lower Cotton Valley Formation, Reservoir A, was fully defined in Office of Conservation Order No. 361-E, effective on and after July 16, 1996.

Plats are available for inspection in the Office of Conservation in **Baton Rouge and Shreveport, Louisiana.**
