On behalf of COMSTOCK OIL & GAS-LOUISIANA, LLC, application is hereby made for a public hearing to receive evidence concerning the issuance of an order pertaining to the following matters relating to the Cotton Valley D Zone, Reservoir A, in the South Drew Field, Ouachita Parish, Louisiana:

1. To permit the applicant to drill, designate and utilize a substitute unit well for CV D RA SUEE, at a bottom hole location in the fractional Section 45, Township 17 North, Range 3 East, Ouachita Parish, Louisiana, which shall be no closer than 600 feet from the West line of said unit, in exception to the well location provisions of Office of Conservation Order No. 904-A-1, effective April 10, 1975. A plat showing said unit and the approximate bottom hole location of said well is attached hereto.
2. To explicitly find that the abovesaid substitute unit well is necessary to efficiently and economically drain a portion of the Cotton Valley D Zone, Reservoir A, in the South Drew Field, underlying CV D RA SUEE, which cannot be efficiently and

economically drained by any existing well in such unit.

3. To designate the Applicant as operator of CV D RA SUEE.
4. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Cotton Valley D Zone, Reservoir A, in the South Drew Field, Ouachita Parish, Louisiana, was defined in Office of Conservation Order No. 904-A, effective March 22, 1973.

The Rules of Procedure of the Commissioner of Conservation pertaining to the Pre-Application Notice requirements, are not applicable to the hearing requested herein, which requires legal notice of only ten (10) days.

Pertinent data regarding this application will be made available for inspection at the offices Blanchard, Walker, O'Quin & Roberts, 400 Texas Street, Suite 1400, Chase Tower, Shreveport, Louisiana 71101. Any person wishing to inspect such data should call Mr. Wm. Copies of such pertinent data can be obtained at the expense of the requesting party.


