Re: APPLICATION FOR PUBLIC HEARING.

Hosston Zone, Reservoir A; Cotton Valley Formation, Reservoir A; and Lower Cotton Valley Zone, Reservoir A; ELM GROVE FIELD, Bossier and Caddo Parishes, Louisiana.

Dear Sir:

J-W OPERATING COMPANY ("Applicant") hereby respectfully applies for a public hearing to consider evidence relative to the issuance of Orders pertaining to the following matters relating to the Hosston Zone, Reservoir A; to the Cotton Valley Formation, Reservoir A; and to the Lower Cotton Valley Zone, Reservoir A; in the Elm Grove Field, Bossier and Caddo Parishes, Louisiana:

1. To permit Applicant to drill, designate and utilize two (2) additional alternate unit wells for HOSS RA SU83, and one (1) additional alternate unit well for HOSS RA SU79, at the locations shown on an attached plat, with the proposed location for the Cupples 13 No. 4 Well on HOSS RA SU83 being in lieu of the location approved for this well by Office of Conservation Order No. 361-A-278, effective February 17, 2004, and with the proposed location for the alternate unit well on HOSS RA SU79 being in lieu of the location approved as the Cupples 18 No. 9 Well by Office of Conservation Order No. 361-A-251, effective December 3, 2003.
2. To permit Applicant to drill, designate and utilize two (2) additional alternate unit wells for CV RA SU90, and one (1) additional alternate unit well for CV RA SU91, at the locations shown on an attached plat, with the proposed location for the Cupples 13 No. 4 Well on CV RA SU90 being in lieu of the location approved for this well by Office of Conservation Order No. 361-B-296, effective February 17, 2004, and with the proposed location for the alternate unit well on CV RA SU91 being in lieu of the location approved as the Cupples 18 No. 9 Well by Office of Conservation Order No. 361-B-271, effective December 3, 2003.
3. To permit Applicant to drill, designate and utilize two (2) additional alternate unit wells for LCV RA SUYY, and one (1) additional alternate unit well for LCV RA SUXX, at the locations shown on an attached plat, with the proposed location for the Cupples 13 No. 4 Well on LCV RA SUYY being in lieu of the location approved for this well by Office of Conservation Order No. 361-E-209, effective September 29, 2004, and with the proposed location for the alternate unit well on LCV RA SUXX being in lieu of the location approved as the Cupples 18 No. 9 Well by Office of Conservation Order No. 361-E-140, effective December 3, 2003.
4. To approve exceptions to the well location provisions of Office of Conservation Order No. 361-A-1, effective October 1, 1972 (applicable to the Hosston Zone, Reservoir A), Office

of Conservation Order No. 361-B, effective October 1, 1973 (applicable to the Cotton Valley Formation, Reservoir A), and Office of Conservation Order No. 361-E, effective July 16, 1996 (applicable to the Lower Cotton Valley Zone, Reservoir A), for each of the proposed wells.

5. To find that each of the proposed alternate unit wells is necessary to efficiently and economically drain a portion of the unit on which it is proposed to be drilled which cannot be efficiently and economically drained by any existing well on such unit.

6. To discuss such other matters as may be pertinent to this application.

The Hosston Zone, Reservoir A, in the Elm Grove Field, Caddo, Webster, Bossier and Bienville Parishes, Louisiana, was defined in Office of Conservation Order No. 361-A-1, effective October 1, 1972, and was further defined in subsequent Orders of the 361-A Series of Orders.

The Cotton Valley Formation, Reservoir A, in the Elm Grove Field, Caddo, Webster, Bossier and Bienville Parishes, Louisiana, was defined in Office of Conservation Order No. 361-B, effective October 1, 1973, and was further defined in subsequent Orders of the 361-B Series of Orders.

The Lower Cotton Valley Zone, Reservoir A, in the Elm Grove Field, Caddo, Webster, Bossier and Bienville Parishes, Louisiana, is defined in Office of Conservation Order No. 361-E, effective July 16, 1996.

Pertinent data concerning this application is available for inspection at the offices of Mr. Joe B. Adams, 9141 Interline Avenue, Suite 3A, Baton Rouge, Louisiana 70809. Any person wishing to inspect such data should call Mr. Adams at (225) 929-6097 during normal business hours in order to arrange a date and time for such inspection. A copy of any such data which is not otherwise available at the Office of Conservation can be obtained from Applicant at the expense of the requesting party.

As provided by the Revised Rules of Procedure, the subject matter of this application does not require the issuance of a pre-application notice; therefore, no such notice has been issued.



Applicant will provide for posting of a copy of the Legal Notice of this hearing and the enclosed plats at a prominent place in the area affected and will cause publication of the Legal Notice in a newspaper published in the general area of Elm Grove Field, all in accordance with the Revised Rules of Procedure. Furthermore, Applicant will mail a copy of the Legal Notice to all Interested Owners, Represented Parties and Interested Parties promptly upon receipt of the Legal Notice from the Commissioner.

Finally, we enclose a check payable to the Commissioner of Conservation for the application fee.




