

LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, APRIL 5, 2005**, upon the application of **YUMA EXPLORATION & PRODUCTION COMPANY**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Bigenerina 2C Zone, Reservoir A**, in the Chacahoula Field, Lafourche Parish, Louisiana.

1. To permit the applicant to drill, designate and utilize its Dibert, Stark & Brown No. 1 Well as a second alternate unit well for the Big 2C RA SUA, such well to be located as shown on the plat submitted with the application.
2. To find that a second alternate unit well is necessary to efficiently and economically drain a portion of the Big 2C RA SUA which cannot be efficiently and economically drained by any other well in the unit.
3. To confirm Cabot Oil & Gas Corporation as the operator of the Big 2C RA SUA.
4. To permit Cabot Oil & Gas Corporation to continue to operate the unit well and first alternate unit well and report production separately from the second alternate unit well which is to be operated and reported by Yuma Exploration and Production Company, Inc.
5. To find that a single unit allowable should be granted for the Big 2C RA SUA and should be recoverable from unit well, either alternate unit well, or from a combination of said wells, with the allocation of the unit allowable between the wells to be arranged between the operators of the respective wells.
6. To find that, except to the extent contrary to the order granted by the Commissioner of Conservation in connection with this application, the provisions of Office of Conservation Order No. 324-RR Series of Office of Conservation Orders should remain in full force and effect.
7. To consider such other matters as may be pertinent.

A plat is available for inspection in the Office of Conservation in **Baton Rouge and Lafayette**, Louisiana.
