**LEGAL NOTICE**

**STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.**

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1<sup>st</sup> Floor, LaSalle Building, 617 North 3<sup>rd</sup> Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, JUNE 7, 2005**, upon the application of **NEW CENTURY EXPLORATION, INC.**

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Pujol Sand, Reservoir C**, in the Gillis-English Bayou Field, Calcasieu Parish, Louisiana.

1. To establish rules and regulations and to create a single drilling and production unit for the exploration for and the production of gas and oil from the Pujol Sand, Reservoir C.
2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed unit with each tract sharing in unit production on a surface acre basis of participation.
3. To provide that any future wells drilled to the Pujol Sand, outside Reservoir C, should be located according to the spacing provisions of Statewide Order No. 29-E.
4. To authorize the Commissioner of Conservation to reclassify the reservoir by supplemental order without the necessity of a public hearing if the producing characteristics of the reservoir change and evidence to justify such reclassification is submitted to and accepted by the Commissioner of Conservation.
5. To consider such other matters as may be pertinent.

The Pujol Sand, Reservoir C was previously defined in Office of Conservation Order No. 252-A, effective September 1, 1954.

A plat is available for inspection in the Office of Conservation in **Baton Rouge and Lafayette**, Louisiana.
