LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, AUGUST 2, 2005**, upon the application of **BP AMERICA PRODUCTION COMPANY**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **18,100' Tuscaloosa Sand, Reservoir A**, in the Moore Sams Field, Pointe Coupee Parish, Louisiana.

1. To permit the Applicant to drill, designate and utilize its LeBeau Estate No. 1 Well as alternate unit well for the 18100 TUSC RA SUD, at the location shown on the plat submitted with the application.
2. To find that the aforementioned well is necessary to efficiently and economically drain a portion of the subject reservoir covered by said unit which cannot be so drained by any existing well within each unit.
3. To grant the applicant a spacing tolerance of no closer than 100 feet from the nearest unit line for the proposed alternate unit well to account for the possible variance between the proposed location and the "as drilled" location.
4. Except to the extent herein designated, to continue in full force and effect the provisions of Office of Conservation Order No. 1063, as amended and supplemented by the 1063-A Series of Office of Conservation Orders and the units created thereby.
5. To consider such other matters as may be pertinent.

The 18,100' Tuscaloosa Sand, Reservoir A, was previously defined in Office of Conservation Order No. 1063, effective May 1, 1979, and redefined in Office of Conservation Order No. 1063-A-3, effective January 13, 1982.

A plat is available for inspection in the Office of Conservation in **Baton Rouge and Lafayette**, Louisiana.
