**LEGAL NOTICE**

**STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.**

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1<sup>st</sup> Floor, LaSalle Building, 617 North 3<sup>rd</sup> Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, AUGUST 2, 2005**, upon the application of **NELSON ENERGY, INC.**

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Upper Cotton Valley Formation, Reservoir A and the Lower Cotton Valley Formation, Reservoir A**, in the Terryville Field, Claiborne and Lincoln Parishes, Louisiana.

1. To authorize Applicant to drill, designate and utilize a substitute unit well and an alternate unit well for UCV RA SUY and for LCV RA SUY at the locations shown on the plat submitted with the application, with the location for the proposed substitute unit well being in exception to the spacing provisions of Office of Conservation Order No. 370-B Series of Orders.
2. To find that each of the above described wells is necessary to efficiently and economically drain a portion of the Upper Cotton Valley Formation, Reservoir A and the Lower Cotton Valley Formation, Reservoir A, underlying these units which cannot be efficiently and economically drained by any existing well within such units.
3. To permit the operator of UCV RA SUY and of LCV RA SUY to produce the allowables assigned to these units from either the substitute unit well, the alternate unit well, or from a combination of such wells, at the option of the operator.
4. To consider such other matters as may be pertinent.

The Upper Cotton Valley Formation, Reservoir A, was defined in Office of Conservation Order No. 370-B-7, effective February 18, 1982.

The Lower Cotton Valley Formation, Reservoir A, was defined in Office of Conservation Order No. 370-B-6, effective February 18, 1982.

A plat is available for inspection in the Office of Conservation in **Baton Rouge and Shreveport**, Louisiana.
