APPLICATION FOR PUBLIC HEARING

Dear Sir:

Sulphur River Exploration, Inc. hereby makes application pursuant to the revised rules of procedure for a public hearing to consider evidence relating to the following matters pertaining to the Cotton Valley Formation, Reservoir A, in the Longwood Field, Caddo Parish, Louisiana:

1. To authorize Sulphur River Exploration Inc. to drill, complete and utilize an alternate unit well on CV RA SUU at the location shown on the attached plat;
2. To authorize the unit allowable for this unit to be recovered from the any of the wells located on the unit, at the discretion of the operator; and
3. To consider and cover such other matters as the Commissioner of Conservation may deem appropriate and necessary under the circumstances.

The Cotton Valley Formation, Reservoir A, in the Longwood Field, Caddo Parish, Louisiana, was defined in Office of Conservation Order No. 123-A-2, effective September 20, 1978; as corrected by Amended Correction to Order 123-A-2, effective March 29, 1983.


