Application is hereby made on behalf of **Whittier Operating, Inc.** for the calling of a public hearing, after legal notice, to consider evidence relative to the issuance of an order pertaining to the following matters relating to the establishment of rules and regulations and the creation of single drilling and production unit for the exploration for and production of gas and condensate from the Homeseekers "C" Sand Reservoir C SUA, in the Rayne Field, Acadia Parish, Louisiana:

1. To establish rules and regulations and to create a single drilling and production unit for the exploration for and the production of gas and condensate from the Homeseekers "C" Sand Reservoir C SUA, in the Rayne Field, Acadia Parish, Louisiana.
2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed unit with each tract sharing in unit production on a surface acreage basis of participation.
3. To provide that any future wells drilled to the Homeseekers "C" Sand, should be located under the spacing provisions of Statewide Order No. 29-E.
4. To authorize the Commissioner of Conservation to reclassify the reservoir by supplemental order without the necessity of a public hearing if the producing characteristics of the reservoir change and evidence to justify such reclassification is submitted to and accepted by the Commissioner of Conservation.
5. To consider such other matters as may be pertinent.

The Homeseekers "C" Sand in the Rayne Field, Acadia Parish, was previously defined in Office of Conservation Order No. 307-V-1, effective December 3, 1991.






PROPOSED UNIT


