LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, DECEMBER 19, 2006**, upon the application of **JAMES A. WHITSON, JR.**

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **V Zone, Reservoir C**, in the East Manchester Field, Calcasieu Parish, Louisiana.

1. To establish rules and regulations and to create a single drilling and production unit for the exploration for and production of gas and condensate from the V Zone, Reservoir C.
2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed unit with each tract sharing in unit production on a surface acreage basis of participation.
3. To designate James A. Whitson, Jr. as operator of the proposed unit.
4. To designate the James A. Whitson, Jr.-Gerald Mott et al No. 1 Well as unit well for the proposed unit.
5. To provide that any future substitute and/or alternate unit wells drilled to the V Zone, Reservoir C, within or outside of the unit created herein, should be located in accordance with the spacing provisions of LAC 43:XIX.1901 et seq. (Statewide Order No. 29-E).
6. To provide that the Commissioner of Conservation should be authorized to reclassify the reservoir by supplemental order without the necessity of a public hearing if the producing characteristics of the reservoir change and evidence to justify such reclassification is submitted to and accepted by the Commissioner of Conservation.
7. To consider such other matters as may be pertinent.

The V Zone, Reservoir C, is hereby defined as being that gas and condensate bearing zone encountered between the depths of 4,571 feet and 4,778 feet (electrical log measurements) in the James A. Whitson, Jr.- Gerald Mott et al No. 1 Well, located in Section 12, Township 10 South, Range 7 West, Calcasieu Parish, Louisiana.

A plat is available for inspection in the Office of Conservation in **Baton Rouge** and **Lafayette**, Louisiana.
