**LEGAL NOTICE**

**STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.**

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1<sup>st</sup> Floor, LaSalle Building, 617 North 3<sup>rd</sup> Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, DECEMBER 5, 2006**, upon the application of **KCS RESOURCES, INC.**

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Lower Cotton Valley Formation, Reservoir A**, in the Terryville Field, Lincoln Parish, Louisiana.

1. To authorize KCS Resources, Inc. to drill, complete and utilize an additional alternate unit well for LCV RA SUTT, at the exceptional location shown on the plat submitted with the application.
2. To authorize KCS Resources, Inc. to drill, complete and utilize an additional alternate unit well for LCV RA SUI, at the exceptional location shown on the plat submitted with the application.
3. To authorize KCS Resources, Inc. to drill, complete and utilize an additional alternate unit well for LCV RA SUP, at the exceptional location shown on the plat submitted with the application.
4. To determine that there is a need for additional alternate unit wells as indicated to efficiently and effectively recover hydrocarbons underlying the units on which they are to be located.
5. To authorize the unit allowable these units to be recovered from the existing wells located on the units, the proposed wells, or any combination thereof, at the discretion of the operator.
6. To consider such other matters as may be pertinent.

The Lower Cotton Valley Formation, Reservoir A, was fully defined in Office of Conservation Order No. 370-B-6, effective on and after February 18, 1982; and has been redefined as to certain units by Office of Conservation Order No. 370-B-64, effective January 10, 2006.

A plat is available for inspection in the Office of Conservation in **Baton Rouge and Shreveport**, Louisiana.
