LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, DECEMBER 12, 2006**, upon the application of **GOODRICH PETROLEUM COMPANY, LLC**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Cotton Valley Formation, Reservoir A, SU86 and SU74**, in the Bethany-Longstreet Field, Caddo and DeSoto Parishes, Louisiana.

1. To permit applicant, Goodrich Petroleum Company, LLC to drill, designate and utilize the Goodrich Petroleum Company, LLC-Evans 21 No. 1 Well as an alternate unit well for the CV RA SU68, such well to be at the location shown on the plat submitted with the application.
2. To permit applicant, Goodrich Petroleum Company, LLC to drill, designate and utilize the Goodrich Petroleum Company, LLC-R. Evans 16 No. 1 Well as an alternate unit well for the CV RA SU74, such well to be at the location shown on the plat submitted with the application.
3. To grant a single unit allowable for the CV RA SU68 and CV RA SU74 and to permit the operator of each unit to produce said unit allowables from the unit well, the proposed alternate unit well, or from a combination of the wells, at its option.
4. To make a specific finding that such proposed alternate unit wells are necessary to effectively and efficiently drain a portion of the CV RA SU68 and CV RA SU74 which cannot be efficiently and economically drained by any other well within each unit.
5. To confirm Goodrich Petroleum Company, LLC as operator of the CV RA SU68 and CV RA SU74.
6. To find that, except to the extent contrary to the order granted by the Commissioner of Conservation in connection with the hearing held on this application, the provisions of Office of Conservation Order No. 289-J Series of Orders shall remain in full force and effect.
7. To provide that the Commissioner of Conservation should be authorized to reclassify the sand and reservoir by supplemental order without the necessity of a public hearing if the producing characteristics of each reservoir changes and evidence to justify such reclassification is submitted to and accepted by the Commissioner of Conservation.
8. To consider such other matters as may be pertinent.

The Cotton Valley Formation, Reservoir A, was initially defined in Office of Conservation Order No. 289-J, effective March 1, 1974, as amended and supplemented by 289-J Series of Office of Conservation Orders.

A plat is available for inspection in the Office of Conservation in **Baton Rouge and Shreveport**, Louisiana.
