Dear Mr. Commissioner:

Application is hereby made on behalf of **Goodrich Petroleum Company, L.L.C.** for the calling of a public hearing, after ten days legal notice, to consider evidence relative to the issuance of an order pertaining to the following matters regarding the Cotton Valley Formation, Reservoir A, SU 68 and SU 74, Bethany-Longstreet Field, Caddo and DeSoto Parishes, Louisiana, for which rules and regulations were established and drilling and production units were created by the Office of Conservation Order No. 289-J, effective March 1, 1974, as amended and supplemented by 289-J Series of Office of Conservation Orders.

1. To permit applicant, Goodrich Petroleum Company, L.L.C. to drill, designate and utilize the Goodrich Petroleum Company, L.L.C.-Evans 21 No. 1 Well as an alternate unit well for the CV RA SU 68, such well to be at the location shown on the plat attached hereto and made a part hereof;
2. To permit applicant, Goodrich Petroleum Company, L.L.C. to drill, designate and utilize the Goodrich Petroleum Company, L.L.C.-R. Evans 16 No. 1 Well as an alternate unit well for the CV RA SU 74, such well to be at the location shown on the plat attached hereto and made a part hereof;
3. To grant a single unit allowable for the CV RA SU 68 and CV RA SU 74 and to permit the operator of each unit to produce said unit allowables from the unit well, the proposed alternate unit well, or from a combination of the wells, at its option;
4. To make a specific finding that such proposed alternate unit wells are necessary to effectively and efficiently drain a portion of the CV RA SU 68 and CV RA SU 74 which cannot be efficiently and economically drained by any other well within each unit.
5. To confirm Goodrich Petroleum Company, L.L.C. as operator of the CV RA SU 68 and CV RA SU 74;
6. To find that, except to the extent contrary to the order granted by the Commissioner of Conservation in connection with the hearing held on this application, the provisions of Office of Conservation No. 289-J Series of Orders shall remain in full force and effect;

7. To provide that the Commissioner of Conservation should be authorized to reclassify the sand and reservoir by supplemental order without the necessity of a public hearing if the producing characteristics of each reservoir changes and evidence to justify such reclassification is submitted to and accepted by the Commissioner of Conservation, and
8. To consider such other matters relating to the subject reservoir as may be appropriate and justified by the evidence presented at the public hearing.

The Cotton Valley Formation, Reservoir A, Bethany-Longstreet Field, DeSoto Parish, Louisiana was initially defined in Office of Conservation Order No. 289-J, effective March 1, 1974, as amended and supplemented by 289-J Series of Office of Conservation Orders.

Attached hereto and made a part hereof is a plat outlining the CV RA SU 68 and CV RA SU 74, Bethany-Longstreet Field, Caddo and DeSoto Parishes, Louisiana, and a list of the names and addresses of the interested owners, represented parties and interested parties to whom this notice is being sent. It is hereby certified that a reasonable effort was made to ascertain the names and addresses of all interested owners, represented parties and interested parties.

A copy of the list of the names and addresses of the interested owners, represented parties and interested parties is not being mailed to those parties along with this application. Should any such party desire a copy of this list, however, we will be glad to provide one upon request.
