LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, MARCH 7, 2006**, upon the application of **CRAWFORD ENERGY OPERATING COMPANY**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **8700' Sand, Reservoir A and the Cib Op Zone, Reservoir A**, in the Bayou Gentilly Field, Plaquemines Parish, Louisiana.

1. To establish rules and regulations governing the exploration for and production of gas and condensate from the 8700' Sand, Reservoir A and the Cib Op Zone, Reservoir A.
2. To create a single drilling and production unit for this sand and this zone and to force pool and integrate all separately owned tracts, mineral leases and other property interests within the units so created.
3. To designate a unit operator and a unit well for the units so created.
4. To provide that any wells drilled outside of the 8700' Sand, Reservoir A and the Cib Op Zone, Reservoir A, shall be in accordance with the spacing provisions of Statewide Order No. 29-E.
5. To provide that the Commissioner may reclassify the reservoirs by supplemental orders and without the necessity of a public hearing should such reclassification be warranted, based on evidence furnished the Commissioner.
6. To consider such other matters as may be pertinent.

The 8700' Sand, Reservoir A, is hereby defined as that gas and condensate bearing sand encountered between the electrical log measured depths of 8,951' and 8,990' (8,697' to 8,733' true vertical depths) in the Crawford Energy Operating Company - Robin No. 1 Well, located in Section 17, Township 15 South, Range 14 East, Plaquemines Parish, Louisiana.

The Cib Op Zone, Reservoir A, is hereby defined as that gas and condensate bearing zone encountered between the electrical log measured depths of 11,020' and 11,116' (10,865' to 10,949' true vertical depths) in the Crawford Energy Operating Company - Delacroix No. 1 Well, located in Section 17, Township 15 South, Range 14 East, Plaquemines Parish, Louisiana.
