Application is hereby made on behalf of **D-S-B PROPERTIES, INC.**, (Applicant), to the Commissioner of Conservation for a public hearing to consider evidence relative to the issuance of an Order pertaining to the following matters relating to the Travis Peak Zone, Greenwood-Waskom Field, Caddo Parish, Louisiana:

1. To permit the applicant to designate and utilize their Querbes No. 6 Well as a substitute unit well for TP SU90, in lieu of the location approved by Office of Conservation Order No. 270-126, effective September 7, 2005, for the production of gas and condensate from the Travis Peak Zone, Greenwood-Waskom Field, Caddo Parish, Louisiana, in exception to the spacing provisions of Office of Order No. 270-1, such unit and well shown on the attached plat and made a part hereof.
2. To find that a substitute unit well, at the location shown on the attached plat, will efficiently and effectively drain the TP SU90.
3. To consider and cover such other matters as the Commissioner of Conservation may deem pertinent and appropriate.

The Travis Peak Zone, in the Greenwood-Waskom Field, Caddo Parish, Louisiana, was defined in Office of Conservation Order No. 125-A, effective August 1, 1947.


