

LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, APRIL 25, 2006**, upon the application of **HILCORP ENERGY COMPANY**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Planulina I Zone, Reservoir B**, in the Kings Bayou Field, Cameron Parish, Louisiana.

1. To designate the Hilcorp Energy Company - Theriot No. 1 Well (SN 219459) as a substitute unit well for the PLAN I RB SUA, as shown on the plat submitted with the application.
2. To designate the Pioneer Exploration, LTD. - Theriot No. 1 Well (SN 218433) as an alternate unit well for the PLAN I RB SUA, as shown on the plat submitted with the application.
3. To designate Hilcorp Energy Company as the unit operator for the PLAN I RB SUA. The currently designated unit operator is Pioneer Exploration, Ltd., Successor to Transworld Exploration & Production, Inc.
4. To permit the operator to produce the unit allowable from the proposed substitute unit well, the proposed alternate unit well, or from both wells, at its option.
5. To continue in full force and effect the provisions of Office of Conservation Order No. 638-HH-1 and the existing unit created thereby, except as herein specified.
6. To consider such other matters as may be pertinent.

The Planulina I Zone, Reservoir B, was fully defined in Office of Conservation Order No. 638-HH-1, effective February 10, 2004.

A plat is available for inspection in the Office of Conservation in **Baton Rouge and Lafayette**, Louisiana.
