LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, MAY 2, 2006**, upon the application of **J-W OPERATING COMPANY**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Hosston Zone, Reservoir A; the Cotton Valley Formation, Reservoir A; and the Lower Cotton Valley Zone, Reservoir A**, in the Elm Grove Field, Bossier and Caddo Parishes, Louisiana.

1. To permit Applicant to drill, designate and utilize four (4) alternate unit wells for HOSS RA SU82 at the locations shown on the plat submitted with the application.
2. To permit Applicant to drill, designate and utilize a substitute unit well and three (3) alternate unit wells for CV RA SU85 at the locations shown on the plat submitted with the application.
3. To permit Applicant to drill, designate and utilize a substitute unit well and three (3) alternate unit wells for LCV RA SU90 at the locations shown on the plat submitted with the application..
4. To approve exceptions to the spacing provisions of Office of Conservation Order No. 361-A-1, effective October 1, 1972; Office of Conservation Order No. 361-B, effective October 1, 1973; and Office of Conservation Order No. 361-E, effective July 16, 1996, for any of the proposed wells, the location of which, as shown on the plats submitted with the application, does not comply with the spacing provisions in such Orders.
5. To find that each of the proposed wells is necessary to efficiently and economically drain a portion of the unit on which it is proposed to be drilled which cannot be efficiently and economically drained by any existing well on such unit.
6. To consider such other matters as may be pertinent.

The Hosston Zone, Reservoir A, was defined in Office of Conservation Order No. 361-A-1, effective October 1, 1972, and was further defined in subsequent Orders of the 361-A Series of Office of Conservation Orders.

The Cotton Valley Formation, Reservoir A, was defined in Office of Conservation Order No. 361-B, effective October 1, 1973, and was further defined in subsequent Orders of the 361-B Series of Office of Conservation Orders.

The Lower Cotton Valley Zone, Reservoir A, was defined in Office of Conservation Order No. 361-E, effective July 16, 1996.

Plats are available for inspection in the Office of Conservation in **Baton Rouge and Shreveport**, Louisiana.
