Camerina-Marginulina Texana Zone, Reservoir B  
East Manchester Field  
Calcasieu Parish, Louisiana**

Dear Sir:

Application is hereby given on behalf of **EBR Energy, LP** ("Applicant") for a public hearing to consider evidence relative to the issuance of an order pertaining to the following matters relating to the Camerina-Marginulina Texana Zone, Reservoir B, in East Manchester Field, Calcasieu Parish, Louisiana:

**CAMERINA-MARGINULINA TEXANA ZONE, RESERVOIR B**

1. To establish rules and regulations governing the exploration for and production of gas and condensate from the Camerina-Marginulina Texana Zone, Reservoir B.
2. To create a drilling and production unit for the exploration and production of gas and condensate from the Camerina-Marginulina Texana Zone, Reservoir B, such proposed unit being shown on the attached plat and being designated CAM-MT RB SUA.
3. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed unit with each tract sharing in unit production on a surface acreage basis.
4. To provide that the Commissioner of Conservation may reclassify the reservoir by Supplemental Order and without the necessity of a public hearing should such a reclassification be warranted based on evidence furnished to the Commissioner.
5. The Camerina-Marginulina Texana Zone was previously defined in Exhibit No. 1 under Docket No. 06-647 as that gas and condensate bearing interval encountered between the electric log depths of 9,550 feet and 10,715 feet in the Entex, Doucet No. 1, located in Section 8, Township 10 South, Range 6 West, Calcasieu Parish, Louisiana.

6. To consider such other matters as may be pertinent.

Pertinent data concerning this application is available for inspection at the office of Bryan S. Groves, 110 Oil Center Drive, Building 13, Lafayette, Louisiana 70503. Any person wishing to inspect such data should call Bryan S. Groves at 337/233-8032 during normal business hours in order to arrange a date and time for such inspection. A copy of any such data which is not otherwise available at the Office of Conservation can be obtained from Applicant at the expense of the requesting party.

In compliance with the Revised Rules of Procedure, a pre-application conference was provided, but no request for a conference was received and therefore, none was held.

Pursuant to the Revised Rules of Procedure, Applicant has made a reasonable effort to obtain the names and addresses of all Interested Owners, Represented Parties and Interested Parties to whom this notice of this application is being sent and has attached hereto a list of the names and addresses of such parties. A copy of the unit plat is enclosed herewith and a copy of this letter and of the attached plat is being sent to the District Manager of the Lafayette District of the Office of Conservation and to the Interested Owners, Represented Parties and Interested Parties as shown on the attached list.

Applicant will provide for posting of a copy of the Legal Notice of this hearing and the enclosed plat at a prominent place in the area affected and will cause publication of the Legal Notice in a newspaper published in the general area of the Subject Field, all in accordance with the Revised Rules of Procedure. Furthermore, a copy of the Legal Notice will be mailed to all Interested Owners, Represented Parties and Interested parties promptly upon receipt of the Legal Notice from the Commissioner.

Finally, we enclose our check payable to the Office of Conservation in the amount of \$755.00 for the application fee.


