

LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, AUGUST 8, 2006**, upon the application of **CENTURY EXPLORATION HOUSTON, INC.**

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **DISC 15 RA SUB**, in the Bayou Postillion Field, Iberia Parish, Louisiana.

1. To permit applicant, Century Exploration Houston, Inc., to drill, designate and utilize the Century Exploration Houston, Inc.-Cotton Land Corporation No. 1 as an alternate unit well for the DISC 15 RA SUB, such well to be at the location shown on the plat submitted with the application.
2. To confirm Century Exploration Houston, Inc. as the operator of the DISC 15 RA SUB.
3. To make a specific finding that such proposed alternate unit well are necessary to effectively and efficiently drain a portion of the DISC 15 RA SUB which cannot be efficiently and economically drained by any other well within the unit.
4. To grant a single unit allowable for the DISC 15 RA SUB and to permit the operator of the unit to produce said unit allowable from the unit well, the alternate unit well, or from a combination of the wells at its option.
5. To find that, except to the extent contrary to the order granted by the Commissioner of Conservation in connection with the hearing held on this application, the provisions of Office of Conservation Order No. 386-Y-2 remain in full force and effect.
6. To provide that the Commissioner of Conservation should be authorized to reclassify the sand and reservoir by supplemental order without the necessity of a public hearing if the producing characteristics of each reservoir change and evidence to justify such reclassification is submitted to and accepted by the Commissioner of Conservation.
7. To consider such other matters as may be pertinent.

The Discorbis 15 Sand, Reservoir A, was previously defined in Office of Conservation Order No. 386-Y-2, effective August 9, 2005.

A plat is available for inspection in the Office of Conservation in **Baton Rouge** and **Lafayette**, Louisiana.
