Dear Mr. Commissioner:

In accordance with the Rules of Procedure for Conducting Hearings Before the Commissioner of Conservation of the State of Louisiana, application is hereby made on behalf of **Petrohawk Operating Company** for the calling of a public hearing, after legal notice, to consider evidence relative to the issuance of an order pertaining to the following matters relating to the CAM 1-3 Zone, Reservoir A, West Parcperdue Field, Vermilion Parish, Louisiana.

1. To create a single drilling and production unit of approximately 423 acres for the CAM 1-3 Zone, Reservoir A, designated as the CAM 1-3 RA SUA, West Parcperdue Field, Vermilion Parish, Louisiana, all as shown more particularly on the attached plat;
2. To establish rules and regulations governing the exploration for and production of gas and condensate from the said unit;
3. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the unit so created, with each tract sharing in unit production on a surface acreage basis of participation;
4. To consider such other matters relating to the subject reservoirs as may be appropriate and justified by the evidence presented at the public hearing.

The CAM 1-3 Zone, Reservoir A in the West Parcperdue Field is hereby defined as being that gas and condensate bearing zone encountered between the measured depths of 15,630 feet and 16,560 feet (electrical log measurements) in the Hassie Hunt Trust-Remy Boudoin Unit 1 No. 1 Well, Section 23, Township 11 South, Range 3 East, Vermilion Parish, Louisiana.

In accordance with the Rules of Procedure for Conducting Hearings Before the Commissioner of Conservation of the State of Louisiana, the Commissioner of Conservation, the District Manager of the Lafayette District of the Office of Conservation and all interested owners, represented parties and interested parties known to the applicant after a reasonable search were notified in writing in the pre-application notice dated July 6, 2006 that a conference to discuss the proposed application was tentatively scheduled for 10:00 a.m. on Thursday, July 27, 2006. It was stated at that time that this conference would be held only if a request to confer were received by the undersigned within ten (10) calendar days after the date of the pre-application notice. No requests to confer were received either in writing or by telephone and, in accordance with the Rules of Procedure, the tentatively scheduled conference **WILL NOT BE HELD**.


