**LEGAL NOTICE**

**STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.**

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1<sup>st</sup> Floor, LaSalle Building, 617 North 3<sup>rd</sup> Street, Baton Rouge, Louisiana, at 9:00 a.m. on **WEDNESDAY, JANUARY 18, 2006**, upon the application of **J-W OPERATING COMPANY**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Hosston Zone, Reservoir A; the Cotton Valley Formation, Reservoir A; and the Lower Cotton Valley Zone, Reservoir A**, in the Elm Grove Field, Bossier and Caddo Parishes, Louisiana.

1. To permit Applicant to drill, designate and utilize an additional alternate unit well for HOSS RA SU78, CV RA SU84 and for LCV RA SU94, at the location shown on the plats submitted with the application, in exception to the spacing provisions of Office of Conservation Order No. 361-A-1, effective October 1, 1972; Office of Conservation Order No. 361-B, effective October 1, 1973; and Office of Conservation Order No. 361-E, effective July 16, 1996.
2. To find that the proposed additional alternate unit well is necessary to efficiently and economically drain a portion of each of the units on which it is proposed to be drilled which cannot be efficiently and economically drained by any existing well on such unit.
3. To consider such other matters as may be pertinent.

The Hosston Zone, Reservoir A, was defined in Office of Conservation Order No. 361-A-1, effective October 1, 1972, and was further defined in subsequent Orders of the 361-A Series of Office of Conservation Orders.

The Cotton Valley Formation, Reservoir A, was defined in Office of Conservation Order No. 361-B, effective October 1, 1973, and was further defined in subsequent Orders of the 361-B Series of Office of Conservation Orders.

The Lower Cotton Valley Zone, Reservoir A, was defined in Office of Conservation Order No. 361-E, effective July 16, 1996.

Plats are available for inspection in the Office of Conservation in **Baton Rouge and Shreveport**, Louisiana.
