APPLICATION FOR PUBLIC HEARING

Dear Sir:

KCS Resources, Inc. hereby makes application pursuant to the revised rules of procedure for a public hearing to consider evidence relating to the following matters pertaining to the Lower Cotton Valley Formation, Reservoir A, in the Terryville Field, Lincoln Parish, Louisiana:

1. To authorize KCS Resources, Inc. to drill, complete and utilize the T. L. McCrary, et al 14 No. 3 Well as alternate unit well for LCV RA SUNN at the exceptional location shown on the attached plat;
2. To determine that there is a need for alternate unit well on LCV RA SUNN as indicated to efficiently and economically recover hydrocarbons underlying this unit which cannot be recovered by any other well located on the unit;
3. To authorize the unit allowable LCV RA SUNN to be recovered from the unit well, the proposed alternate unit well, or any combination thereof, at the discretion of the operator; and
4. To consider and cover such other matters as the Commissioner of Conservation may deem appropriate and necessary under the circumstances.


The subject matter of this application does not require the issuance of a Pre-Application Notice.


