APPLICATION FOR PUBLIC HEARING

Dear Sir:

Petro-Chem Operating Company, Inc. hereby makes application for a public hearing to consider evidence relating to the following matters pertaining to the Haynesville Formation, Reservoir A, in the Northwest Colquitt Field, Claiborne Parish, Louisiana:

1. To establish two additional drilling and production units for the exploration for and production of oil and gas and/or gas and condensate from the Haynesville Formation, Reservoir A, in the Northwest Colquitt Field, Claiborne Parish, Louisiana, to be designated HA RA SUL and HA RA SUM as shown outlined on the plat attached hereto and made a part hereof.
2. To force pool and integrate all of the separately owned tracts, mineral leases and other property interests located within the proposed units in accordance with Section 10, Title 30, of the Louisiana Revised Statutes of 1950, with each tract sharing in unit production on a surface acreage basis of participation.
3. To designate Petro-Chem Operating Company, Inc. as operator of HA RA SUL and to designate the Petro-Chem Operating Company, Inc. - Owens 19-1 No. 1 Well as the unit well for HA RA SUL at the location shown on the attached plat;
4. To extend the field rules for the Haynesville Formation, Reservoir A, in the Northwest Colquitt Field, to the proposed units except to the extent inconsistent herewith;

5. To consider and cover such other matters as the Commissioner of Conservation may deem appropriate and necessary under the circumstances.

The Haynesville Formation, Reservoir A, in the Northwest Colquitt Field, Claiborne Parish, Louisiana, was defined in Office of Conservation Order No. 669-C, effective September 9, 1997.




