On behalf of COMSTOCK OIL & GAS-LOUISIANA, LLC, application is hereby made for a public hearing to receive evidence concerning the issuance of an order pertaining to the following matters relating to the Hosston Zone, in the Logansport Field, DeSoto Parish, Louisiana:

1. To permit the applicant to drill, designate and utilize its D.A. Johnson No. 1 - Alt. Well as an alternate unit well for HOSS SU53, at the location shown on the plat attached hereto, in exception to the well spacing provisions of Office of Conservation Order No. 28-S-4, effective July 22, 1981.
2. To explicitly find that the proposed alternate unit well is necessary to drain a portion of the Hosston Zone in the Logansport Field underlying HOSS SU53, which cannot be efficiently and economically drained by any existing well in such unit.
3. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Hosston Zone in the Logansport Field, DeSoto Parish, Louisiana, was redefined in Office of Conservation Order No. 28-S, effective April 21, 1970.
